		Personal goods can circulate freely within the European Community. However, some particularly sensitive items remain subject to regulation. The list of these products has been established to take account of health, security, consumption, environment, and cultural considerations. For moves from outside the EL if documents are missing and the importer need his household effects immediately, you can ask the customs office for information on the existir possibilities. The importer may authorise anoth person to handle the formalities on his behalf. The customs duties are to be paid in cash or with bank or postal cheques. If the payment is made by cheque, the cheque must be certified by your bank. The customs supplies on request of the importer a free trade card "carte de libre circulation" for example for camera, lens, radio, etc. This document proves the correct condition of the objects during a 10-year period.
